a regular basis, with the money being removed directly from paid wages. It automatically removes funds from a person's bank account and awards those funds to the other party.

Once the writs are issued and properly and timely served, the judgment debtor has the ability to contest the garnishment.

Garnishment on salaries are usually issued for 60 or 90 days. The returnable date must not fall on a weekend or

federal holiday. The returnable date on a writ is never issued for less than 30 days and never more than 90 days. Banks are always given 30 days.

For writs of garnishment, a motion to quash would state that the order to issue a garnishment was improper. The debtor can file a motion to quash a writ of garnishment when he receives notice of a garnishment that has not yet commenced, or he can file it after the garnishment has already started.
