The searches are a set of standard enquiries raised by the purchaser's conveyancer with a particular authority, for example the local search is raised with the local council, the drainage & water search with the water authority etc. Conveyancing searches deal only with the legal aspects of the purchase. Buyer’s Conveyancer confirms they have acceptable results from their searches, are happy with the answers to pre-contract enquiries and are in receipt of a mortgage offer (if any). Seller and buyer agree on a completion date and contracts are formally “exchanged” - meaning both parties are legally committed to the transaction.

Some conveyancing searches and enquiries are the same for every residential transaction, these include water and drainage enquiries, enquiries of

the seller and enquiries of the local authority, amongst others. Other searches and enquiries will differ depending on the area or on environmental features. If the area is a known mining area, for example, it would be necessary for the buyer's solicitor to carry out a mining search.
