LLP Members' Written Resolution. Unlike limited companies the legislation governing LLPs does not

specify how LLPs conduct their meetings, use written resolutions and record their internal decisions. It is however likely that the governing LLP agreement will specify how internal decisions should be reached and recorded. Clause 15.6 of the Simply-Docs long form LLP Agreement provides that the designated members of the LLP may pass decisions by written resolution instead of holding meetings.

The most common type of LLC corporate resolutions is the LLC Operating Agreement.
