Under a recent European Union (“EU”) Directive, the EU Mandatory Disclosure Regime (“MDR”) imposes mandatory

reporting of potentially aggressive tax planning arrangements involving EU Member States (also known as “DAC6”). EU MDR came into force on 25 June 2018 however the deadline for disclosure is fast approaching, by 31 August 2020.
