In order to communicate with each other and leave their stories for the new generation, humans have been using the power of images and symbols since the beginning of the human history. It is this greatest purpose – communication – that makes human beings to construct their system of signs and

symbols – their language – to make the world meaningful. This essay is an attempt to deal, in general, with question of representation – the production of meaning through language. In first part of the essay we define, shortly, three theories of representation, with the main focus on the constructionist theory. In the second part we will show how the constructionist approach has to do with representation, the relationship between them. And, in third part we will explain the importance that these theories have in relation with communication. We will focus our attention on structuralist semiotics – in Ferdinand de Saussure and Roland Barthes works.

Strategies for Supporting Inclusion and Diversity in the Academy *Springer Nature*

From Bombay to Bollywood *NYU Press*

From Bombay to Bollywood analyzes the transformation of the national film industry in Bombay into a transnational and multi-media cultural enterprise, which has come to be known as Bollywood. Combining ethnographic, institutional, and textual analyses, Aswin Punathambekar explores how relations between state institutions, the Indian diaspora, circuits of capital, and new media technologies and industries have reconfigured the Bombay-based industry's geographic reach. Providing in-depth accounts of the workings of media companies and media professionals, Punathambekar has produced a timely analysis of how a media industry in the postcolonial world has come to claim the global as its scale of operations. Based on extensive field research in India and the U.S., this book offers empirically-rich and theoretically-informed analyses of how the imaginations and practices of industry professionals give shape to the media worlds we inhabit and engage with. Agent, Person, Subject, Self *Oxford University Press*

This book offers both a naturalistic and critical theory of signs, minds, and meaning-in-the-world. It provides a reconstructive rather than deconstructive theory of the individual, one which both analytically separates and theoretically synthesizes a range of faculties that are often confused and conflated: agency (understood as a causal capacity), subjectivity (understood as a representational capacity), selfhood (understood as a reflexive capacity), and personhood (understood as a sociopolitical capacity attendant on being an agent, subject, or self). It argues that these faculties are best understood from a semiotic stance that supersedes the usual intentional stance. And, in so doing, it offers a pragmatism-grounded approach to meaning and mediation that is general enough to account for processes that are as embodied and embedded as they are articulated and enminded. In particular, while this theory is focused on human-specific modes of meaning, it also offers a general theory of meaning, such that the agents, subjects and selves in question need not always, or even usually, map onto persons. And while this theory foregrounds agents, persons, subjects and selves, it does this by theorizing processes that often remain in the background of such (often erroneously) individuated figures: ontologies (akin to culture, but generalized across agentive collectivities), interaction (not only between people, but also between people and things, and anything outside or in-between), and infrastructure (akin to context, but generalized to include mediation at any degree of remove).

Memory and Methodology *Routledge*
