Georgia Bankruptcy Means Test. If you would like to file a Chapter 7 bankruptcy you must pass the Georgia means test. The test only applies to higher income filers which means that if your income is below the Georgia median for your household size you are exempt from the test and may file a Chapter 7. If your income is higher than the Georgia median you will need to complete the means test calculation to determine if you can pay back a portion of your unsecured debts through a Chapter 13 ...

Georgia Bankruptcy Means Test - Chapter 7?

Legal aid in Georgia includes a few organizations that can assist you when filing Chapter 7 bankruptcy. In a Chapter 7 bankruptcy you wipe out your debts and get a "Fresh Start". Chapter 7 bankruptcy is a liquidation where the trustee collects all of your assets and sells any assets which are not exempt. (see Georgia Exemptions) The trustee sells the assets and pays you, the debtor, any amount exempted. The net proceeds of the liquidation are then distributed to your creditors with a commission taken by the trustee overseeing the distribution.

If your disposable income is more than \$10,000 per year for the next 5 years, Georgia law prohibits a Chapter 7 and requires you to repay at least a portion of your debts with a Chapter 13 bankruptcy. There are, however, special circumstances that could still allow you to qualify to file Chapter 7.

To obtain a bankruptcy discharge in a Chapter 7 bankruptcy in Georgia, you must meet income requirements to file under Chapter 7.
