ISO 27002:2013 Version Change Summary - Information Shield

Update 2013-09-25: This blog post was updated according to the final version of ISO 27002:2013 that was published on September 25, 2013. In my previous blog post I analyzed the changes between the old ISO 27001 (published in 2005) and the 2013 revision; naturally, controls from ISO 27001 Annex A cannot change without changing ISO 27002 because the essence of these two standards is to be aligned.

ISO 27002:2013 - Main changes in the structure

ISO/IEC 27002:2013 has been updated to reflect the many changes which have taken effect in ISO/IEC 27001, and is fully aligned to the new 2013 version of ISO 27001. For example: The number of controls in ISO/IEC 27002 has been changed to match the number in ISO/IEC 27001, and ISO 27002 now specifies 35 control objectives, each of which is supported by at least one control, giving a total number of 114.

The ISO/IEC standard was revised in 2005, and renumbered ISO/IEC 27002 in 2007 to align with the other ISO/IEC 27000-series standards. It was revised again in 2013. It was revised again in 2013. Later in 2015 the ISO/IEC 27017 was created from that standard in order to suggest additional security controls for the cloud which were not completely defined in ISO/IEC 27002.

By the way, ISO 27001:2013 has in Annex A the control “A.12.1.2 Change management,” which requires that changes to the organization, business processes, information processing facilities, and systems that affect information security are controlled. As you can see, the requirement exists, but there are no particular instructions on how to implement the control (i.e., Change procedure is not a mandatory document), so in this article I’ll suggest one of the ways to manage changes.

Perhaps the most significant change is that the chapter on ‘risk assessment and risk treatment’ has been removed. With ISO/IEC 27002:2013 there are now only 114 controls, as opposed to the original 133, and they are listed under 14 headings, rather than the original eleven.

What likely changes are expected with the updated ISO/IEC ...

ISO 27002 documents many aspects of change control that should be included, ranging from simple documentation of the changes through to consideration of the time for deployment to avoid negative business impact. This control like others in A.14 also aligns with documented procedures in A.12.1.2.

ISO 27001 Annex A.14 - System Acquisition, Development and ...

All those elements are defined in ISO 27001, but not in ISO 27002. The differences between the controls in ISO 27002 and ISO 27001. The controls in ISO 27002 are named the same as in Annex A of ISO 27001 – for instance, in

ISO 27002, control 6.1.2 is named "Segregation of duties," while in ISO 27001 it is "A.6.1.2 Segregation of duties."

ISO 27001 vs. ISO 27002 - What's the difference?

Annex A of the new ISO/IEC 27001 naturally reflects ISO/IEC 27002:2013.

However, perhaps the most significant change is that the chapter on risk assessment and risk treatment has been removed. The following sections show how the controls in the new standard map onto the ISO/IEC 27002:2005 controls and which ISO/IEC 27002:2005 controls have been deleted.
