Federal law and Texas require new MLOs, (or MLOs in an unapproved status), to complete the Mortgage Loan Originator SAFE Comprehensive Course pre-licensure education. This education includes 3 hours of Federal law, 3 hours of ethics (which shall include fraud, consumer protection, and fair lending issues), 2 hours of non-traditional mortgage lending, plus 12 hours of undefined education (electives).
