Notification should be made within 72 hours of the controller becoming aware of the breach.

Transparency requirements under the GDPR. Under the accountability principle laid out in Article 5.2, a data controller "must be able to demonstrate that personal data are processed in a transparent manner in relation to the data subject." These transparency obligations begin at the data collection stage and apply "throughout the life cycle of processing."
