Sample Motion To Quash

A motion to quash a subpoena should be granted "where the futility of the process to uncover anything legitimate is inevitable or obvious" or "where the information sought is utterly irrelevant to any proper inquiry." See *Kapon v. Koch*, 23 N.Y.3d 32, 38 (2014) (quoting *Anheuser-Busch, Inc. v. Abrams*, 71 N.Y.2d 327, 331-32 (1988)).

(1) Notice of objections or motion to quash. A participant, or a recipient of a subpoena, who does not intend to comply with a discovery request must notify in writing the participant seeking discovery within a reasonable time in advance of the date on which a response or other action in conformance with the discovery request is due.

Motion to Quash evidence. A Motion to Quash evidence asks a judge to suppress a piece of evidence because there is a problem with it. If the motion is granted, the evidence can't be used in court. A Motion to Quash evidence is typically used in a criminal case and often called a "Motion to Suppress Evidence." Some examples of when a Motion to Quash evidence can be used:

If a party thinks that a subpoena asks for documents that have nothing to do with the case, or asks for too much information, the party can make a motion to quash the subpoena. See CPLR 2304. Or, a party can make a motion to make the other side give the discovery that he or she was asked for by making a motion to compel. See CPLR 3124.

A motion to quash a subpoena is a request for the court to determine whether it has personal jurisdiction over the accused defendant. If the ISP subpoena letter recipient lives outside of the state in which the lawsuit was filed, the court will quash the subpoena and render the subpoena null and void.
