Lawsuit Answer Template. An answer is a formal document filed

by the defendant (s) with the proper court in which they were initially served a complaint. The answer will deny or admit the allegations, line-by-line as requested in the complaint. Additionally, the answer is important to bring any defenses the defendant may want to raise such as the claim is beyond the statute of limitations or that there is no claim for which damages is owed.
