It is a devastating portrayal of a ruler brought down by his own oath. *OEDIPUS AT COLONUS* provides a fitting conclusion to the life of the aged and blinded king, while *ANTIGONE* depicts the fall of the next generation through the conflict between a young woman ruled by her conscience and a king too confident in his own authority.
